It has been a great summer and the weather has been very warm with very little rain. September starts the process of working on the Town Budget for 2012. With the two percent tax cap everyone will be working to keep within the guide lines set by our elected officials. With the cost of operating the town increasing each year by more the then tax cap some changes will be needed to keep within the tax cap.

The South Street and York Road Water District is still in the process of trying to obtain funding. The USDA (Department of Agriculture) has stopped all funding for 2011. Several water districts in Western New York

and Genesee County are waiting for funding. All water districts are in competition for funding and whoever meets the criteria for Grant Money will get funding.

The Town Board has approved the Highway Contract with the Teamsters Union and has sent the contract to the union office for their approval and signature.

Waste Water Treatment Plant News.....

Please note that The Sewer Plant Operator, V.R.I has changed their name to Camera Group Inc.

The operation and the maintenance cost of the treatment plant increased four Percent per year for the last two years. The cost of chemicals, sludge removal, and paying the plant operators has outpaced your quarterly payments. The cost for the plant operator for 2012 will be \$31,050 for the year. The cost for the chemicals and other needs to operate the sewer plant average about \$2900.00 per month with expected increases in the next year. If any major repair cost occurs, the budget will be short of funds to pay the bills in the future. The Town Board will be looking at the budget to make sure there is available money to meet expenses for 2012.

Dear Pavilion Residents,

It is that time of year again to be thinking of exemptions. **I will be mailing out renewal forms.** The Senior Citizens exemption, the Enhanced STAR Exemption and the Agricultural Exemption must be applied for every year, those that have signed up for IVP (Income Verification Program), through the Enhanced STAR program do not need to reapply. These forms **must** be returned to the Assessor's office no later than **March 1, 2012**. For any one that may be turning 65 in the calendar year of 2012 (ex. if you turn 65 in September 2012) **please** come in and see me prior to March 1, 2012. This is to see if you may qualify for the enhanced STAR, I will need proof of age and proof of income, the income must be 2010 income and the adjusted gross income must be below \$79,050.

If you own your home and it is your primary residence, this includes those that live in a Manufactured Home and you have not done so already you may apply for the Basic STAR exemption, this exemption is applied towards school taxes. This must be applied for no later than March 1, 2012.

My office hours are on Monday Mornings from 8:00 am - 12:00 pm and Wednesday from 8:00 am - 12:00 pm, 1:00 pm - 4:30 pm from. Please call first as I may be out doing field review, or taking photo's. If I am out taking photo's I will have a sign on the car "Assessor Town of Pavilion."

I am also available in the LeRoy Town office Located at 48 Main Street, LeRoy; Monday afternoon, Tuesday's, Thursday's and Friday's from 8:00 am - 4:30 pm.

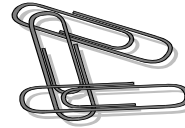

DOG NEWS:

All dogs 4 months of age and older are required to be licensed through your Town and to have a current rabies vaccination at time of licensing. The fee to license or renew the dog license are \$5.00 for unaltered dogs and \$13.00 for unaltered dogs. When licensing or renewing please provide a current rabies vaccination certificate.

Each dog, cat, and ferret must be accompanied by someone who can control it.

Dog, cat, and ferret vaccinations are free for Genesee County residents. A \$5.00 voluntary donation, per dog, cat, or ferret, is requested to offset clinic expenses. Non-residents must pay a mandatory \$5.00 fee for each dog, cat, and ferret immunized.

A huge thanks to the dog owners who renew their dog licenses on time.

MARRIAGE NEWS:

Marriage licenses are available at any town clerk office in NYS. The license needs to be obtained 24 hours prior to the time of the marriage. Applications are valid for 60 days once obtained. Both the bride and groom need to appear in person to obtain the license application. If either applicant has been previously married all divorce documents need to be presented to the clerk at the time of application. The fee for the Town of Pavilion marriage application is \$40.00.

TOWN/COUNTY TAXES:

Town/County tax bills will be sent out around the first of January 2012. They can be paid by mail or in person at the Town Clerk's office. There is no penalty if payment received by January 31st. Thereafter there is a 1% penalty for February and a 2% penalty for March. After March 31st taxes need to be paid at the Genesee County Treasurer's Office in Batavia.

Conservation News:

The 2010-2011 sporting licenses and deer management permits went on sale August 16th. Applicants have until close of business October 1st to apply for Deer Management Permits (DMPs) through the instant lottery. A first-come first-served DMP application period will begin on November 1st for any WMUs with leftover DMPs.

PAVILION FIRE DEPARTMENT NEWS

I have several newsworthy items from the Fire Department. First I would like to thank the First Baptist Church for inviting department members to the Red and Blue Sunday Service on September 11th. We enjoyed the fellowship and the food. One thing that made the event very meaningful was that at the same time we were attending an appreciation event for public and community servants, other members of your Community Fire Dept. were in the flood ravaged Binghamton area relieving their fire and rescue crews.

We would also like to thank the community for another successful Firemen's Auction. Our major fund raiser for the year could not happen without your participation.

In the Western New York area, the name Mercy Flight has become synonymous with life saving medical helicopters. On August 22 you may have seen their newest and largest helicopter in the sky's over Pavilion. We had the honor of hosting the first ground school training since the arrival of the new 6.5 million dollar ship. We have used their service six times this year to transport patients to advanced care hospitals.

We are fortunate to have several new people join the department this year along with some existing members that advanced their skill level through training. Five members completed the 90 hour New York State Firefighter I class and three members completed the 125+ hour Emergency Medical Technician course.

Lastly let me remind everyone about Fire Prevention Week which is October 9th through the 15th. Take time that week to replace the batteries in smoke and carbon monoxide detectors, review home escape plans, survey your home for hazards to correct and be sure your house number is visible from the road.

As always we are in need of new members. We encourage you to consider becoming a volunteer to help the community you live in. Applications can be obtained from any firemen.

ZONING & CODE ENFORCEMENT OFFICER UPDATE ...

This year NYS adopted the new 2011 of Building Code. NYS also adopted Leandra's Law. Both deal with Carbon Monoxide (CO) detectors. This Law and codes are retroactive and DO APPLY ALL RESIDENCES. Every residence has to have CO detectors. How many and their placement varies by the when the residence was constructed, the floor layout and occupancy of your residence. Please feel free to contact this office to aid in the determination of number and placements of detectors.

The Town of Pavilion Town Board, at its last meeting, adopted a new Guide for Resolving Zoning Violations in Pavilion. This guide directs this office to identify or respond to complaints concerning Zoning Violations along with my many other duties. However, this new Guide does outline the various steps that will be taken to eliminate Zoning Violations in this town in a step-by-step method so that a fair and equitable solution is assured. As I will be conducting a road review of the whole Town, landowners, tenants and residents should also be inspecting their own property to be sure that they are not in violation. If a landowner, tenant or resident is in doubt about a particular situation please call this office at 584-2023 or email to tdgoldenrod@yahoo.com and request information or an inspection. Copies of the Zoning Ordinance and the new Guide including a new complaint form are available for review at the Town offices or will soon be on the Town web site www.townofpavilion.com.

As the heating season is nearing, a reminder that all Solid Fuel Burning devices (wood, pellet, coal, etc) and chimneys related to them require a building permit and inspection.

In closing remember to change the batteries in your smoke & CO detectors when you turn the clock back this fall

From Our Legislator....

Tax Cap. Those two words mean very different things depending on whether you are a taxpayer, a New York State elected official, or a local government or school official.

This summer a tax cap was passed by the State Legislature and signed into law by the Governor. Basically, the tax cap sets an upper limit on the amount of taxes that counties, municipal governments, fire districts, schools and other taxing districts are allowed to raise through real property taxes. Okay, that seemed reasonable and desirable. NYS taxpayers welcomed the idea of a tax cap, believing the State had finally put a stop to tax bills that constantly increased.

However, the people putting the tax cap legislation together deliberately bypassed the fact that taxes cannot be controlled without also controlling spending. So, in a great spirit of sharing, our State's elected officials shifted responsibility for some of their over-the-top spending down to their constituents: us. So, not necessarily just with money, we citizens have been left to pay for the State's unchecked fiscal irresponsibility. That's the tax cap in a nut shell.

In the meantime, Genesee County is putting together its 2012 budget. With the tax cap in place, the County is left with the costs of providing the services NYS has said we absolutely must provide (these are called mandates). The Governor claims that counties are still rich and can afford to pick up the tab for State-imposed mandates without raising local taxes. Well, I'm here to tell you, Genesee County government has been very careful to live within our means, mandates and all.

Now, however, with rising costs but an imposed tax cap, Genesee County has no place to go except to cut more personnel and reduce non-mandated services. I personally am finding that very hard to stomach. Yet, I certainly cannot support tax increases just to satisfy New York State's appetite for expensive programs and self-centered focus. Actually, I am confident that we could have a much smaller county government if we didn't have to pay for New York State's gluttony and self-serving priorities.

How can we help Genesee County survive our financial crunch? Buy locally; keep sales tax here in the County. For every \$8 we spend in Genesee County on taxable items, NYS keeps \$4 and returns \$4 to the County. Of the \$4 Genesee County gets back, the County keeps a large portion and shares the rest with the Towns and the City of Batavia.

The Pavilion Community Food Pantry

The Pavilion Community Food Pantry has had the usual busy summer. Not only do we continue to serve those who have need, but we have also recently completed a one year contract with Food link to help keep our shelves filled.

Food link, out of Rochester, is part of a large network of groups that connects surplus food of all kinds and origins with people who need help providing for their family's nutritional needs. In this area, interestingly enough, it was started by the Thomas's English Muffin people, but is now heavily supported as well by factories such as Kraft and Barilla, and companies such as Wegmans. There are many others. Everything we need is **not** available through Food link, as their supply varies seasonally as well as by availability, and they depend on donations or token payments. Also, we don't have the capacity to store items needing refrigeration (dairy and fresh). However, it helps that, whatever IS available, is very reasonably priced (well below market costs), and is delivered directly to the Pantry rather than requiring us going out shopping for it. We'll try it for a year and see how it goes.

Meanwhile, a BIG thanks to all those of you who remember us regularly. You remain the backbone of our organization. We've been making periodic pick-ups from local businesses, and the folks at the churches and several other groups donate faithfully. We have recently had several generous checks from community members, which are important to fill the shelves when donations flag in the cereal cupboard or we are out of rice or hot dogs or potato flakes, and nothing is available from Food link. We always need cereal, both hot and cold; soups of all kinds; canned fruit; gravy; spaghetti noodles and pasta sauce; canned baked or cooked beans; condiments; boxed meals like mac-and-cheese and Hamburger Helper or Manwich. It's nice to have toothbrushes and toothpaste, soap, shampoo, deodorant, and other personal supplies on hand, too, and someone's eyes are sure to light up if they see pet food on the shelf. Yes, we make room for Fido and Kitty, too! We have had some school supplies, but quantities of those are better sent right to school where they are needed. Believe me, the office staff will know what to do with them!

We have had several calls offering fresh garden produce, and we'd love to be able to take it. How generous so many of you have been to offer! However, we do not have any way to store it, and as sure as I accept a bunch of green beans or corn, no one will call for a week, and it will all have to be tossed away. We do not take donations home, personally, ever, so perishable items like lettuce and squash are apt to, literally, perish.

A final thanks to all those wonderful people who help us insure that the elderly go to bed fed and the children go to school nourished and ready to learn; who care that there are unemployed, underemployed, sick and disabled among us. You know who you are. Thanks for stepping up and helping your neighbors.

One last important reminder: the Pavilion Community Food Pantry is denomination-free and available to anyone who has need, emergency, temporary, or otherwise. While it is housed in the Methodist Church, and is supported by the local churches and other community groups, as well as individuals, the only requirements are residence in the Pavilion or Wyoming Central School Districts, and personal need. It's an honor system; we trust that expressed need is real need, and you don't have to belong anywhere.
