January 2012 began a time of change for the Town of Pavilion with the election of Town Supervisor, Theron (Ted) Howard and Town Clerk/Registrar, Cindy (Lucinda) Starr. In addition to the elected officials, Robert (Rob) LaPoint was appointed to the Planning Board as an Alternate.

Ted Howard was elected as Town Supervisor in November of 2011. Ted, a graduate of SUNY Buffalo and the University of Miami School of Law, has practiced law in LeRoy, NY since 1979. Among numerous civic groups and organizations, Ted served as a member of the Pavilion Central School Board of Education for 11 years. He has also served as Town Justice in the Town of Pavilion and as Town Prosecutor responsible for vehicle and traffic matters.

Ted enjoys reading, carpentry, gardening and is fascinated with his latest avocation which is beekeeping.

Cindy Wellman Starr, was elected to the position of Town Clerk, A lifelong resident of our community, Cindy graduated from Pavilion Central School in 1972 and is married to Randy Starr. Both the Starr and Wellman families have farmed the land for over 100 years. The Starr family arrived in Pavilion in 1818 and received an award in 1979 for being a Century Farm. The sewer plant continues to have its problems, but we will be considering an addition settling tank which should be a relatively economical solution that will last for a significant time.

To all of you who have unlicensed cars or scrap metal in your yards, I remind you that scrap is high right now and the Town is taking the first steps to vigorously enforce both our zoning code and the NYS code against unlicensed vehicles. It might be a good idea to take care of these before you receive a citation. We cannot correct decades of accumulation overnight, but we are starting on the worst cases first and will eventually get to all the violations. The Board and I are asking for your cooperation in trying to make Pavilion a better place to live. Each of us can make a difference one day at a time.

NEWS FROM OUR HIGHWAYS & BYWAYS

Mother Nature was good to our area during the winter of 2012. Highway Superintendent, John Strathearn, refers to this past season as a "light winter" (the mildest winter in his 30 plus years with the highway department) that saved taxpayers' dollars. John reported that winter highways will typically use up to 1200 tons of salt to keep our roads safe for travelers. This year only 600 tons were removed from the salt building which is located next to the Town of Pavilion Offices. John also indicated that funds for fuel and labor were actually cut in half because of the mild winter.

Lack of need for snow and ice removal on the 41 miles of highways in the town of Pavilion, created a head start for the crew's other duties which are maintenance and repairs of the roads. Part of these duties include the removal of animals that have been hit by vehicles, but John reports that because of a reduction in the deer population this has become less of a problem. The department is also responsible for the purchase and maintenance of highway equipment.

John was elected as Highway Superintendent in 1992 when Chuck Davis retired after nearly 27 years of serving the community. Chuck replaced Jimmy Hettrick in 1965 when he resigned to go into the milk truck business.

In addition to John Strathearn's 30 years with the Highway Department (20 years as Highway Superintendent), other department members who have served for many years include; Doug Elliott, 22 years, Dennis Kingsley, around 20 years, Peter Greene, 17 years and Jamie Cleveland 11 years.

If you happen to see any of the highway crew you may want to let them know how much we appreciate all the services which they provide to keep us rolling along on our highways and byways!

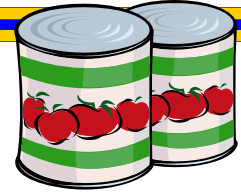
- In 1813 at the first Bellona (LeRoy, **Pavilion** and Stafford) Town meeting, twenty-eight men were voted to serve as overseers of highways. The men would also serve as fence viewers. Repairs and construction of highways were not to exceed the sum of \$150.
- On March 6th, 1883 during the annual Pavilion Town Board meeting held at the Pavilion Center Grange Hall, it was decided that a sum of one hundred and fifty dollars be raised by taxes for highway purposes.

The Pavilion Community Food Pantry

2011 was a year of changes for the Pantry, all good ones. We joined Foodlink, and our grants for the year totaled over \$1100 dollars, which is huge, considering a case of canned vegetables might cost \$1.50 through Foodlink... or nothing at all. The only downside is that particular items we need may not be available when we need them, such as pasta sauce, or don't arrive predictably when ordered. Basics such as canned fruit and vegetables, soup, tuna, peanut butter and jelly, cereal, and rice are nearly always on the list at very reasonable prices, so our food dollars are stretching.

Also, by means of a Foodlink grant, we were able to partner with the Pavilion Central School to provide a limited amount of food for children identified by the school as needing extra nutrition sources for weekends and school holidays. That program has been in place since late spring, and when the grant ran out, the Pantry was able to pick up the costs of it. These are amazingly minimal, something like 50 cents per child per week. Foodlink delivers the food prepackaged directly to the school every Tuesday, and we have no labor involved in that program.

Some other random notes:

*Cash and other donations are up this year. Harris Corporation donated 127 turkeys. The Interfaith Thanksgiving Service at St. Mary's and Ash Wednesday offering at Pavilion United Methodist Church, the Cub Scouts food drive, and the mail carriers' drive helped keep the shelves stocked. Mary Immaculate and PUMC members remain faithful, and East Bethany United Presbyterian Church has increasingly become a reliable donor. The Pavilion First Baptist Church has supported the Pantry this year as well.

* Donations from Pavilion Central School organizations has been remarkable, especially the Elementary School staff and Ms. Johnston's Girls' Service League. The Food Pantry was the recipient of the Elementary School's Holiday Fund donation, gifts donated by students, parents, faculty and staff, which was substantial.

* Blessings upon everyone who donated to Community Chest this year. Their support of the Pantry has been solid and was even more generous this year!

*Students are becoming involved, personally. Several have donated hours to help shelve and distribute goods, and a home-schooled student flexes her super-coupons skills to provide personal toiletries, as well as birthday bags, Christmas cookie decoration kits, and valentines. There were also 100 canned goods to celebrate 100th Day!

*The monks of the Abbey on the Genesee continue providing us with freshly baked bread. This saves us a substantial amount of money, and is a better choice nutritionally for the families. We may also soon be receiving sandwich bread, thanks to the initiative of a local farmer.

* Wilson Farms accepts our coupons for milk and eggs for clients. During the summer months, clients were invited to pick up fresh produce by coupon from The Farmer's Wife at their Rt. 63 location.

* Pat Bradley, Jackie Roberts, Sue Kinney, Debbie Davis, and Dick Heye have been joined by two new volunteers, Marilyn Palotti of East Bethany and Jim Conway of Pavilion. They meet the Foodlink truck and unload deliveries. We continue to be exceedingly grateful for the skills of Henry Janes, who keeps our books and makes sure we don't overspend! Mary Eisenhard worked hard to include some Seniors and preschoolers in St. Mary's Giving Tree at Christmas. They were very grateful and pleased with their gifts.

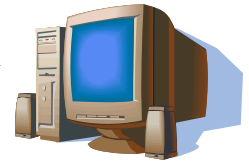

Dog Licenses:(Any dog age 4 months or older must have a license.) **Fees:** \$5.00 altered, \$10.00 unaltered

Marriage Licenses : Marriage Licenses are available at any Town Clerk Office in NY State

- Licenses are required to be obtained 24 hours prior to the time of marriage
- Applications are valid for up to 60 days once obtained
- Both parties need to appear in person to obtain the license application
- License Fee is \$40.00 \$10.00 for certified copies



Fishing Licenses: Anyone 16 years or older must obtain a fishing license. Proof of residency is required.

Licenses are valid from October 1 to September 30

Hunting Licenses: Available with licenses valid from October 1 to September 30

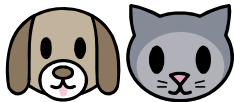

The Town of Pavilion Planning Board is busy handling several applications for Land Separations and various permits. Along with the standard type of requests, the Board members are constantly trying to consider future growth patterns so that the continued use of the area will be as safe and pleasing as it is today.

The Town Board filled the open Alternate Member position by naming Robert LaPoint to the position. In addition the Town Board has named an interim Code Enforcement Officer/Zoning Enforcement Officer (CEO/ZEO) to fill the open position. . Donald Roberts, The Wyoming County CEO has consented to work with the Town of Pavilion until it can employ a qualified and certified person for the position. Since the Town of Pavilion Planning Board represents the residents and landowners of this Town, we invite and encourage all to attend the meetings and observe how the system works. FIRE DEPARTMENT NEWS

The Pavilion Community Fire Company would like to remind everyone of the open burning laws that took effect October 14, 2009. No brush burning from March 16 through May 14. No burning of household trash at any time. Small camp fires, cooking fires, and ceremonial fires are allowed but must be attended. There are provisions for agricultural burning. For complete information go to DEC or GLOW websites, call the County Office of Emergency Services, or stop at the Fire Station.

There have been some changes to the Board of Fire Commissioners, the Board that oversees the operation of the Fire Department on behalf of the Town. We would like to thank Brian Elliott and Cliff Elliott who stepped down as Chairman and Secretary respectively. Their years of service in those positions are greatly appreciated. Jeff Finch was elected Chairman of the Board in January. We welcome new board member, Dick Herman, and new Secretary, Deborah Donnelly. The other board members are John Huenemoerder, Dave Tillotson, and Bill Kegler.

The Department has been working on upgrades to its vehicles. We will be removing two trucks from service in the future and replace them with a single multi-role vehicle. The process was begun over a year ago. The truck will be manufactured by KME Kovatch of Pennsylvania and take approximately 9 months to deliver. The truck will have several new fire and rescue concepts built into it. Our fire department has always been a forward thinking department that tries to integrate new technology and techniques into our operations. This truck will reflect that.

Pavilion Bicentennial— Bellona or baloney???

Do you believe we are nearly 200 or 171 years old? According to Genesee County research, a new town by the name of Bellona (named for the Roman Goddess of War) was formed on June 8, 1812. This township included LeRoy, Pavilion, and Stafford. Bicentennial celebrations are being planned to commemorate the anniversary. Lynne Belluscio continues to publish history and upcoming events on the township of Bellona in the *LeRoy Pennysaver and News*.

Although these records show our town to be 200 years old, our Town Historian, Virginia Rigoni's records show that the actual Town of Pavilion was formed from Covington, Wyoming County on May 19, 1841. A New England settler, Harmon Betts, was among folks who were farmers and merchants in the area around 1825. Mr. Betts, a native of Saratoga Springs, named the village *Pavilion* after a hotel located in Saratoga. (More information on the history of the Town of Pavilion can be found on the Town's website.)

Could it be that the Town of Pavilion has two birthdays? One to celebrate this year and then another bicentennial on May 19, 2041. It seems that we have many reasons to celebrate the Town of Pavilion by any name, appreciate the hardships of the settlers, and be proud of our little community.

Dear Residents,

Each year the deadline for filing exemptions such as senior citizens, disability, and agricultural renewal is **MARCH 1st**. For a complete listing of exemptions and details visit the Town of Pavilion website. For future reference: Please note if you are turning 65 in 2012 and have not yet applied for the *Enhanced STAR*, or if you are turning 65 in 2013 you must apply for the *Enhanced STAR* by March 1, 2013. (You must show proof of income which must be below \$79,050 and you will need proof of age.)

I have been out doing field review on parcels which have had assessment changes. If your parcel has had an assessment change, you will have received notification on or around **April 16, 2012**. Information on my available hours for an **INFORMAL HEARING** will be stated on the notice. You **MUST** call to arrange an appointment of 15 minutes for each parcel that you will be discussing. If you do not receive a notice you may call my office to see if there has been a change.

If you choose not to schedule an **INFORMAL HEARING** and are in disagreement with your assessment, **Grievance Day** will be held on Wednesday, **May 23, 2012**. At this time of planning, the tentative afternoon hours will be from 2:30-4:30pm and evening hours from 6:00-8:00pm.

Please call for more information and note that appointments are recommended.

All current information on record is available on the County OARS System website: www.oarsystem.com/ny/genesecounty/default.asp. If you should find a discrepancy, please contact me at either my Pavilion or LeRoy office.

Cardboard and Boxboard: Corrugated cardboard and cereal boxes, cracker, gift, tissue, shoe, etc. all go on floor in corner of town building.



Compact Fluorescent Lights: Accepted in Pavilion or take to Home Depot or Lowes (free)



Electronic Waste: Accepted at Pavilion: computers, monitors, microwaves, household and rechargeable batteries, etc. .



Plastic Bags and Wrap: Newspaper bags, bread bags, cereal/cracker box liners, produce bags, dry cleaning bags, zip-type (zip removed) baggies, furniture wrap, paper towel wrap, drink case wrap, napkin package wrap, stretch/ shrink wraps (clean & dry), toilet paper wrap. Accepted at any: Tops, Wegman's, Walmart, Target, Lowes, Home Depot, Staples, and more.



Rechargeable batteries: Accepted at Pavilion, Home Depot, Lowe's, Target, Walmart.



Car Batteries: Accepted at Pavilion or sell to a scrap dealer or take for free to a service station.



Cell Phones: Accepted at Pavilion, Home Depot, a charity, or any cell phone company.
